ORDINANCE NO. 2020-006

AN ORDINANCE LEVYING AND ASSESSING TAXES OF THE
HARVARD FIRE PROTECTION DISTRICT
MCHENRY COUNTY, ILLINOIS FOR 2020

BE IT ORDAINED by the Board of Trustees of the Harvard Fire Protection District,
McHenry County, Illinois, as follows:

Section One: That the sum of **NINE HUNDRED EIGHTY SIX THOUSAND ONE HUNDRED FOUR DOLLARS (\$986,104.00)** assessed and levied from and against all taxable property within the limits of the said Harvard Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2020, and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

AMOUNTS TO BE RAISED BY TAX LEVY:

CORPORATE FUND

Corporate Fund Levy \$442,907.00

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE FUND

Ambulance Fund Levy \$543,197.00

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

Section Three: If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of remaining portions of the Ordinance.


Section Four: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.


